PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by the Chairman, Raymond Whitaker.

Raymond Whitaker responded to questions that were raised during public comments at the August 15th School Board meeting. The areas of concern included new teachers, teachers with less than 5 years of teaching experience, policies, Student Code of Conduct, exit interviews and service contract bids.

PUBLIC COMMENTS

Public comments were made by Reverend Dr. Ronnie Sidney regarding the absence of African-American principals in the schools. He stated that at the closing of the old Essex High School and opening of the new schools, a promise was made that an African-American would always serve as principal of Essex Intermediate School. He and other community members feel that the promise should be enforced in at least one of the schools. He added, "Justice delayed is justice denied".

Public comments were given by Bethsaida White (President of the Rappahannock Industrial Alumni Association), supported by Patricia Holmes and Dr. Griselda Bayton,

regarding the use of Essex Intermediate School for the RIA Annual Scholarship Banquet. They were dissatisfied with the condition of the cafeteria and requested a refund for the fees that were paid.

CORRECTIONS/ADDITIONS TO THE AGENDA

There were no corrections or additions to the agenda.

SUPERINTENDENT'S REPORT

The Superintendent's Star Student Award and Backpacks were awarded to Britney Gray (Grade 10), Destinie Gray (Grade 8) and Jordan Yocum (Grade 7) for being selected to perform with the Moscow Ballet at George Mason University in their production of the The Nutcracker.

Certificates were awarded to Marjorie Brown (Special Education Teacher) for receiving a Master's Degree and Angela Barley (Administrative Assistant) for receiving a Bachelor's Degree.

The Superintendent's Starfish Award and Pins were awarded to transportation personnel. They were recognized for all of their hard work and dedication. Board Chair, Raymond Whitaker, commended the drivers for their enthusiasm that he observed on the first days of school.

Superintendent, Dr. Scott A. Burckbuchler, thanked and commended everyone involved for a wonderful and awesome opening of school. He feels positive energy and is excited about the year, looking forward to working together, as we seek excellence. He also thanked the School Board for their hard work and support. Enrollment is at 1,496 which is close to last year's enrollment. An official report will be given at the end of September. Dr. Burckbuchler also invited everyone to attend the dedication ceremony that will be held at Essex High School on October 18, 2014 at 10:00 a.m. He stated that the technology integration packet has been placed in the elementary and intermediate schools. This is the first year for the free breakfast program and student participation is encouraged. The superintendent asked Susan Kellar, Paraprofessional, to share a teacher's license from 1890 that was found on her property. The license had been issued to a teacher in Essex. Mrs. Kellar presented the framed document to Dr. Burckbuchler to be displayed in the School Board Office. Recognition and thanks were also extended to a community member for donating a banner to the football.

Department of Parks and Recreation, Essex County Public Library, and Essex County Public Schools have created a partnership to implement the program. The Read and Roll Program awards fee waivers for programs offered by the Essex County Department of Parks and Recreation. The program is designed to improve overall reading skills for students in Tappahannock Elementary School and Essex Intermediate Schools. The program also requires parent participation.

Mathematics Update- ECPS's Math Coach, Brian Risley, informed School Board members of our current situation and what corrective action the Division is taking to improve our students' performance in Mathematics. Diondra Mercer (T.E.S. Teacher), Nancy McKinley (E.I.S. Teacher) and James Moore (E.H.S. Teacher) gave highlights on their respective schools.
