## **SUPERINTENDENT'S REPORT**

Superintendent, Dr. Scott A. Burckbuchler, thanked building administrators, faculty and staff for a successful first month of school. Dr. Burckbuchler also stated that there are still certain situations that need to be addressed that we are working on.

Mrs. Whitney Orlando and Ms. Katherine Branscomb organized a Writing Across the Curriculum Project in the first grade. ## **Backpack Buddy Program**

On a motion by Denise Hammond, seconded by Keren Ellis, the Board approved the initial concept planning for implementation of the "Backpack Buddy" type of supplemental nutrition for Essex County Elementary Students as presented by Mr. John Clickener.

# **ECPS Bring Your Own Device (BYOD) Policy**

On a motion by Liz Martin, seconded by Keren Ellis, the Board approved the ECPS BYOD Policy as presented by Jon Barnes, Technology Director. The BYOD policy will allow employees and students to bring technology into the schools and allow access to specific services like the internet. This policy will allow students who have signed the BYOD Acceptable Use Policy to connect a personal device to the BYOD wireless network during BYOD learning times. This would be determined by the administration and the classroom teacher. Employees who have an educational use may also bring in a personal device such as a tablet or laptop to use in an educational setting. This policy gives students and teachers a greater educational opportunity by allowing the use of personally owned technology.

# **Resolution for Disability History and Awareness Month**

On a motion by Liz Martin, seconded by Denise Hammond the Board approved the Resolution for Disability History and Awareness Month as presented Mrs. Tara Roane, Director of Special Education and Student Services. One-fifth of all Americans have disabilities, including almost one million people in Virginia. During October, Disability History and Awareness activities provide an opportunity to create greater public awareness for individuals with disabilities, with the goal of full inclusion in their communities.

## **Bus Lease Agreement**

On a motion by Keren Ellis, seconded by Denise Hammond, the Board approved the Bus Lease Agreement as presented by Annette Thompson, Director of Accounting. The lease purchase enables Essex County Schools to replace aging buses in a cost effective manner.

### ECPS Policy Manual Update –Policy EEA-Student Transportation Services

On a motion by Liz Martin, seconded by Keren Ellis, the Board approved Policy EEA-Student Transportation Services, as presented at the September 15, 2014. The revised policy is to clarify that if a student chooses not to use ECPS transportation, the parent/legal guardian shall assume full responsibility for and hold the School Board, its agents, servants, and employees harmless from any legal liability, injury, or damage to the person or property of others in connection with the student's transportation to and from such regional program. The parent/legal guardian will sign a letter to this regard. Liz Martin requested that the parent letter be clarified to state that students who are allowed to drive themselves will not be prohibited from riding the bus on days that they do not drive.
