## SUPERINTENDENT'S REPORT

Dr. Melvin informed the Board that the budget sub-committee is in the process of drafting the 2012-2013 budget. He stated that the committee is considering a 3% pay increase. This would mean an \$800,000.00 deficit to the budget or a \$500,000.00 deficit without the pay increase. Another factor to consider is the VRS rate increase. He explained that all hinges on the General Assembly's decision.

#### **NEW BUSINESS**

Mrs. Valerie Taylor spoke on behalf of the Essex Education Association. She thanked the Board for the 1% increase this past summer. She mentioned that no raise has been given in the past 3 years and asked that the Board please consider a pay increase in next year's budget.

Mr. Whitaker applauded the members for their efforts and stated that they do deserve an increase. Mrs. Ellis asked that all citizens write to the General Assembly and voice their concerns. Mr. Slaughter asked that they also take the message to the local Board of Supervisors.

Mr. Roy Bray expressed his concern about the Board's decision on a discipline case.

Mrs. Kim Rector spoke on accountability and stated that policies should be reviewed long before an incident occurs.

Mr. Rusty Carlton asked what qualified those persons chosen for the Policy & Procedure Committee. Dr. Melvin stated that the committee members were made up from a variety of areas (i.e. community leaders, parents, educators, law enforcement, and various local organizations).

Mr. Bullis explained the steps taken to replace the seat vacanted by the death of Mary Gaskins.

Mr. Robert Crowther asked if the Board had an attorney. Dr. Melvin stated that the Board does have an attorney.
